## Data protection information regarding the use of photos and/or video recordings in accordance with Art. 13 GDPR

### 2. Purpose of the processing

The photos and/or videos will be used for the purpose of public relations work by the company Dethleffs GmbH & Co. KG and for participation in the prize competition organized in the context of the "90 years" anniversary events.

### 3. Legal basis of the processing

The processing of photos and/or videos (i.e. their collection, storage, etc.) is based on the express consent of the legal guardian(s) of the person(s) concerned, i.e. in accordance with Art. 6 (1) (a) GDPR. The publication of selected image files in (print) publications issued by the organiser(s) and on their website and/or social media channels or the like is a necessary aspect of the public relations work carried out by the organiser(s).

### 4. Categories of recipients of personal data

The photos, videos and/or audio recordings will not be shared with third parties.  
They may be used for public relations purposes in (print) publications issued by the organiser(s) and on their website and/or social media channels or similar.

### 5. Storage duration for personal data

Photos, videos and/or audio recordings which are used for the purpose of public relations work by the company Dethleffs GmbH & Co. KG, will be exclusively earmarked for the 90th anniversary campaigns and events as well as for the prize competition, subject to withdrawal of the data subject's consent.

### 6. Your right to withdraw your consent

You are free to withdraw your consent for the processing of the submitted photos and/or videos at any time and with lasting effect by contacting us at the address provided in Section 1. This shall not affect the legality of the data processing carried out on the basis of your consent prior to its withdrawal.

### 7. Rights of data subjects

In accordance with the General Data Protection Regulation you have the following rights:

- a) If your personal data is processed, you have the right to receive information about the stored data concerning you (Art. 15 GDPR).
- b) If incorrect personal data concerning you is processed, you have the right to have it corrected (Art. 16 GDPR).
- c) If the legal requirements are met, you can demand the deletion of the data or a restriction of the processing. You can also appeal against the processing (Art. 17, 18, 21 GDPR).
- d) If you have consented to the processing of your data or a data processing contract exists and the data processing is carried out using automated procedures, you may have the right to data portability (Art. 20 GDPR).

Should you decide to exercise the aforementioned rights, the Data Controller will verify that the legal requirements are met. You also have the right to appeal to the State Commissioner for Data Protection of the State of Bavaria (Landesbeauftragte für Datenschutz des Landes Bayern).



## Participation in the competition "Photo and video campaign – 90-year anniversary".

### 1. Participation

By participating in the competition, the participant agrees to abide by the terms and conditions of entry. Any person aged eighteen years or older who is resident in the Federal Republic of Germany, Austria or Switzerland is eligible to participate. Employees, relatives and sales partners of Dethleffs GmbH & Co KG are excluded from the competition. Participation via competition services or other manipulations of the rules are not permitted. Only one entry per individual is allowed per competition. In case of suspected fraud by an entrant (e.g. unauthorised manipulation of the rules, multiple entries), Dethleffs GmbH & Co KG reserves the right to confiscate the prize (including retrospectively).

### 2. Procedure

Dethleffs GmbH & Co KG invites the participants to send one or more photos matching the topic "90 years of caravanning" to Dethleffs (see address label). To participate in the competition, the participant must submit one or more analogue or digital photos, fill in the mandatory fields and accept the terms and conditions of entry. The closing date for entries is Wednesday, 31 March 2021 at 23:59. The judges' decision is final. The winners will be chosen at random from all participants who submitted the correct answer to the competition question. Dethleffs GmbH & Co. KG will notify the winner by sending an e-mail to the address specified in their entry form.

### 3. Copyright

The participant must be the sole author of the submitted content. The content may not infringe the rights of other individuals. The participant must have the consent of all persons depicted in the content, or in the case of minors, the consent of their parents or legal guardians. Furthermore, the creation of the images and/or recordings may not constitute a violation of applicable laws.

### 4. Use of the submitted content

The participants grant Dethleffs GmbH & Co KG the unlimited right, free of charge, to copy, distribute and make publicly accessible the contents provided by them within the scope of the competition.

### 5. Prizes

In each case, the prizes described in the competition text will be awarded. Cash payments are not possible. Should a prize no longer be available for any reason, Dethleffs GmbH & Co KG reserves the right to replace the prize with an alternative prize of equal or higher value. ### 9. Changes to the terms and conditions of entry – premature termination of a competition

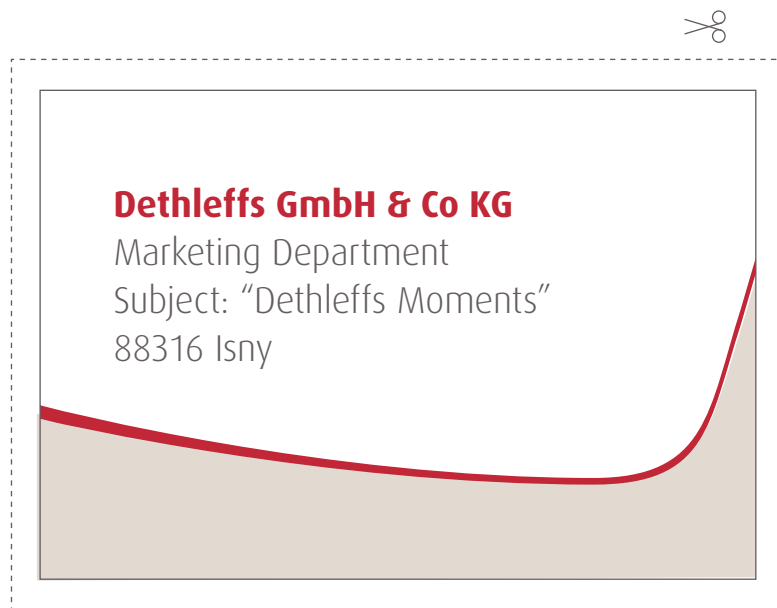
